

**CULBERSON COUNTY GROUNDWATER CONSERVATION DISTRICT
NOTICE OF PUBLIC HEARING
ON APPLICATION FOR A NON-HISTORIC USE PRODUCTION PERMIT(S) (NO. NHUPP-011)**

Notice is hereby given that on Friday, July 12, 2024, commencing at two o'clock (2:00 p.m.) [all times are C.D.T.], the Culberson County Groundwater Conservation District ("District") will conduct a public hearing and possibly take action on the following pending application, which has been deemed administratively complete:

(1) Application by Wylie View Ranch., for a Non-Historic Use Production Permit ("NHUPP"), assigned No. NHUPP-011, which would authorize the applicant to produce groundwater in the District from the Wildhorse Flat Aquifer within the West Texas Bolsons aquifer system in the amount of 1,120.0 acre-feet annually for irrigation use, and 320.0 acre-feet annually for industrial use, with a total groundwater diversion being 1,480 acre-feet annually.

The General Manager of the District, Haley Davis ("General Manager"), has prepared a draft NHUPP for No. NHUPP-011, and this draft permit is available for public inspection on the District's website. The District will conduct a **PUBLIC HEARING** pursuant to its authority under Chapter 8816 of the Texas Special District Local Laws Code, Chapter 36 of the Texas Water Code, and the District's Rules to consider action on No. NHUPP-011 (Wylie View Ranch.), and to provide interested members of the public an opportunity to appear and provide oral or written comments to the District regarding the proposed permits. The public hearing will be at the following location at the indicated date and time:

The General Manager will make a recommendation relating to the District Board's consideration of action on the application for No. NHUPP-011:

- 1) No. NHUPP-011 by Wylie View Ranch to allow for 800 acre-feet of water annually to be used for irrigation use, 360 acre-feet of water annually to be used for industrial use, with total groundwater diversion 1,160 acre-feet of water annually.

Applicant(s) and affected persons may request a contested case hearing on the application, No. NHUPP-011, by submitting such a request in writing to the District no later than 2:00 p.m. on July 7, 2024.

Persons with disabilities who plan to attend the district hearing and who may need auxiliary aids or services, such as interpreters for persons who are deaf or hearing impaired, readers, large print, or braille, are requested to contact Haley Davis, General Manager, at (432) 283-1548, at least five (5) work days prior to the meeting so that appropriate arrangements can be made.
